INFORMATION FOR FILING AN APPEAL

- 1. The filing fee for an Appeal is \$100.00 and must be paid by money order or cashier check, made payable to the Wind River Tribal Court;
- 2. The Notice of Appeal must be filed with the Court within twenty (20) days from the date the Judgment/Order was issued by the Court. (*Three additional days will be given to allow for mailing.*)
- 3. The Clerk will provide a copy of the Notice to Appeal to all parties involved in the original case.
- 4. If you are represented by an attorney all filings will go directly to your attorney. It is their responsibility to provide you with a copy if you would like one.
- 5. Within twenty (20) days from the date you file the Notice of Appeal, you must file an Application for Appeal and give a brief summary of your reasons why the Appeal should be heard. The form allows for "Cause of Action" and "Relief Sought". Please be sure to attach the continuation sheet if you need additional room.
- 6. You must provide the original and one (1) copy for each of the parties who are entitled to service. The Clerk will mail out the copies.
- 7. The other parties to the case are entitled to twenty (20) days to respond to your Application.
- 8. The Chief Judge will decide whether or not your Appeal will be assigned to the Court of Appeals (a panel of three (3) judges) who have not heard your case before.
- 9. Within twenty (20) days after permission to appeal is granted, or within such other time as the court allows, you may file a written brief, memorandum, or statement in support of your appeal. An original and one copy for each party involved in the case shall be filed with the clerk who shall mail one copy, registered or certified mail, return receipt requested, to each interested party. The return receipt shall be filed with the clerk.
- 10. Each interested party shall have fifteen (15) days after receipt of your brief, memorandum, or statement, or such other time as the court allows, within which to file an answer brief, memorandum, or statement if they desire. An original and one copy for each interested party shall be filed with the clerk who shall mail one copy, registered or certified mail, return receipt requested, to each party to the case. The return receipt shall be filed with the clerk

11. No further briefs, memorandum or statements shall be allowed without leave of court.

12. The Appeals Panel will decide whether or not they would like to hear oral arguments or whether they will decide the case based on the briefs.
