INSTRUCTIONS FOR FILING PETITION TO MODIFY DIVORCE DECREE

- 1. The filing fee for a modification of Divorce Decree is \$25.00 which must be paid to the Wind River Tribal Court in the form of a money order or cashier's check.
- 2. If you do not believe you can afford the fee you will need to fill out the request to waive the filing fee that can be provided to you by the court.
- 3. If the Judge approves of your request to waive the fee, the clerk will file your petition.
- 4. You will need to attach a copy of the original Divorce Decree. It is best if you high-light the parts that you are asking the court to modify.
- 5. On the Petition you will need to write out specifically the parts you want to modify and identify them by paragraph number or letter.
- 6. Write specifically what you want the parts to be changed to
- 7. On the attached Affidavit you will need to explain to the court why you want to the changes made.
- 8. File the Request for Setting so the court can set the matter for a hearing.
- 9. Be sure to fill out the Contact Information Sheet completely so the court has information on both parties.
- 10. A copy of your petition must be served on the other party to the divorce. You must file the "Certificate of Service" with the court to provide proof that you have provided the other party with a copy of your petition and what date you provided that copy.
- 11. If you are representing yourself and you would like the courts help to get the other party served then you need to ask the clerk to assist you.
- 12. The Other Party has 20 days from the date they received a copy of your petition to object so a hearing will not be set until that time has expired
