INFORMATION ON EVICTION TITLE XII HOUSING CODE 12-2-4 PROCEDURES

- 1. The Court does not participate in the eviction process of removing a person from a property or residence even if there is a lease or private agreement or not. A Civil Suit may be filed after all remedies have been exhausted pursuant to the Law & Order Code as it applies to evictions or termination of leases.
- 2. The owner of the property or residence must initiate the eviction process.
- 3. Any eviction notice must be in writing, and must be delivered to the tenant by either personal service, certified mail, return receipt requested, or by securely taping a copy of the notice to the main entry door of the premises in such a manner that it is not likely to blow away and by posting a copy of the notice in some public place near the premises, including a tribal office, public store or other commonly frequented place.
 - o The person giving notice must keep a copy of the notice and proof of how it was served.
 - The person being evicted must be given the reason for the eviction and inform the person of their right to make a reasonable reply.
- 4. Eviction must be for good reason including, but not limited to:
 - o Failure to make payments.
 - o Destruction of the property
 - Violation of any agreements concerning the use of the property or residence.
 - o Nuisance, property damage or destruction, injuries to the property, person or peace of other tenants, or injuries or damage to common areas and property.
 - o Conducting illegal activities on the property or in the residence in violation of the Shoshone and Arapaho Code of Tribal Offenses.
 - o Occupying any premises without permission or agreement.
- 5. Eviction notices must be give the tenant the following amounts of days to vacate;
 - o 14 days' notice for failure of payment.
 - o 3 days' notice for serious violations such as injury to the property or injury to a person or serious threat to public health or safety.
 - o 30 days' notice in all other situations.

TITLE XII: HOUSING CODE, SECTION 12-2-4 (7) NOTICE TO QUIT

If the person you are attempting to evict refuses to move after you have taken the previous steps then you will need to issue a **Notice to Quit**.

- A. Except by mutual consent of the parties, no landlord may compel a tenant to vacate any premises in a forceful fashion or way which causes a breach of the peace.
- B. The notice to quit may be served by any tribal or other law enforcement officer or any person appointed by the tribal court for service of process, and it must be served as provided in Section 12-2-4 (3) of this code;
- C. The notice must be addressed to the known occupants of the premises, although unknown occupants need to be named, and it shall state the reason(s) for the notice and state a date by which the occupant must leave the premises and surrender it to the owner;
- D. Any notice which substantially complies with the following form will be sufficient
 - o "TO: (name of tenants) and occupiers of (address of premises or reasonable description of location)
 - o "You are required to quit possession or occupancy of these premises, move out and return the possession of the premises to the landlord on or before (state the date) for the following reason(s) (state what they are)
- E. The notice must provide not less than eight (8) days to vacate the premises, except in cases of nuisance or injuries as provided in Section 12-2-4 (c) of this code.

COURT PROCEDURES SECTION 12-2-5

- 1) Complaint. At any time after the expiration of the time set in the notice to quit, if the tenant or occupant of the premises refuses to quite possession or occupancy of the premises, the landlord may file a complaint in the tribal court for eviction and other relief.
- 2) At this point you must file a civil complaint with the Court. This filing fee is \$100 and you will need to fill out the forms for a civil complaint. You must be prepared to provide the Court with proof that you have exhausted all remedies require in the Eviction/Notice to quit procedures outlines in the previous instructions. (Keep all copies showing you have served/provided the person with the Eviction Notice and Notice to Quit)
