## **FORM IX-12 PETITION FOR ADOPTION**

- 1. **Please read the instructions.** Read <u>all</u> of these instructions before completing this packet to make sure you understand what the Court needs from you to decide if it should grant your request to adopt a child. When you file this Petition, you become known as the Petitioner.
- 2. **Before you file this form**. Make sure you do ALL of the following before filing this Petition:
  - A. Obtain consent of the parents/guardians. If you are related to the child by at LEAST the second degree by blood or affinity, you may file this Petition immediately. You will still need to obtain the consent of the living parents/guardians, but if you have the proper relationship with the child, you may simply have them sign a form saying they consent in order to file this Petition. If you are NOT related to the child by at Least the second degree by blood or marriage (i.e., if you are not a parent, sibling, half sibling, grandparent, aunt or uncle, niece or nephew of the child), you must have the living parents/guardians of the child schedule hearings with the Court to swear before the Court that they consent to give up their parental rights to you.
  - B. If parents/guardians will not consent. If the living parents/guardians of the child will not consent to your adoption of the child, you may not file this petition unless their parental rights have been terminated by a court order. If you believe their parental rights should be terminated, you may fill out a separate packet to file that proceeding first.
  - C. Obtain consent of the child, if applicable. If the child is over age twelve (12), you must have HIS/HER consent as well. Have him/her fill out a consent form in addition to the living parents/guardians.
- 3. **What you will need to attach**. In order to properly fill out this petition, you will need copies of the child's birth certificate and tribal enrollment card, and copies of your tribal enrollment cards. If these are not attached, the Petition CANNOT be filed. You will also need copies of consent forms signed by the current living parents of the child (attached to this packet; please have them fill out), or (if applicable) proof that their parental rights have been terminated by a court order. If the child is over the age of twelve, you will also need to attach a copy of a consent form signed by him/her.
- 4. **Create your petition**. Fill in the blanks below to create your *Petition for Adoption*. After you have completed this form, take it to the Tribal Court for filing.

- 5. **Filing fee.** You must pay a \$100.00 filing fee. This must be in the form of a money order, made payable to "Wind River Tribal Court."
- 6. **After filing.** The following things will happen after you file this Petition.
  - A. *Preadoptive Study*. The law requires that, after you submit this Petition, the Court schedule a social services visit to your home for what is called a "Preadoptive Study." Social services (or possibly BIA) will investigate the suitability of the child for adoption, your ability to financially provide for the child, oral and physical fitness and general background information about the home, and report it back to the court.
  - B. Hearing of Adoption. Within five (5) days of the conclusion of the Preadoptive Study, the Court will schedule a hearing on your Petition. You <u>must</u> appear at this hearing and all people who had to consent to the adoption must appear as well. If they do not, it will be rescheduled until all people needing to consent are present. At this Hearing of Adoption, the judge will examine you, the child, and any other persons consenting to the adoption separately. If the judge is satisfied to the suitability based upon this testimony and the evidence in the Preadoptive Study, you will be granted custody of the child for a Home Trial Period. If you have already had custody of the child for more than one (1) year, the Home Trial Period is not necessary, and the Court may enter a Final Order of Adoption
  - C. Home Trial Period, if necessary. Upon approval of the Court based upon the results of the Preadoptive Study and the Hearing the child must live with you for at least six (6) months before the Court may enter a final adoption order, if he/she had not already been living with you for at least one full year.
- 7. **The Code.** The Shoshone and Arapahoe Law and Order Code sets out all the requirements for asking the Court to petition for an adoption. The Code can be provided to you upon request of the Court Clerk.
- 8. **Regarding legal advice.** If you need legal advice for filling out the Petition, you may contact Legal Aid of Wyoming at 1-877-432-9955. If you qualify for services, someone will be assigned to help you. The Court Clerk cannot provide you with legal advice, they may only help you understand this form so you can fill it out properly.
