- Pay an admission fee of \$25 with this application, subject to return if denied.
- Be subject to review of the Chief Judge to ensure satisfaction that qualifications are met.

Please make sure the following is included with your application:

- Admission Fee of \$25 in the form of cashier's check or money order, if this is your initial application.
- Annual Fee of \$50 in the form of cashier check or money order.
- If this is a renewal application, you must provide verification of fifteen (15) hours of training since your last renewal in the areas of civil, criminal, juvenile or appellate law as outlined in Rule of Court AD-103 of The Shoshone & Arapaho Law & Order Code.
